### FULL 5-YEAR WARRANTY (OIL) 40F Series and R35 Series Burners

The Riello Company warrants its residential oil burners to be free from defects in material and workmanship under normal use and service for 60 months from the date of installation or 66 months from the date of manufacture, whichever date occurs first. This warranty does not extend to equipment subjected to misuse, neglect, accident, acts of God or improper installation. Equipment, which is defective in material or workmanship and is removed within 60 months from the date of installation, will be replaced as follows:

- a. Motors, fuel units, controls, capacitors, coils, photo-resistors, sub-bases, isolators, hydraulic jacks, turbulator disks, blast tubes, and regulator assemblies should be sent or taken to an authorized Riello dealer, wholesaler/distributor for replacement.
- b. Where such local service is not available, with respect to the above-listed components, a returned goods authorization (RGA) should first be requested and then such equipment should be returned PRE-PAID to Riello.
- c. Riello is NOT responsible for any labor cost for removal and replacement of equipment.
- d. Equipment, which is replaced, will carry a warranty equal to the unexpired portion of the original component warranty or one year from the date of replacement, whichever is greater.
- e. The warranty shall not apply if the oil burner was installed incorrectly, misapplied or not serviced annually by a heating contractor whose principal occupation is the installation and service of heating equipment.
- f. The provisions of this warranty cover Riello manufactured parts. Ancillary items not manufactured by Riello such as relays, oil filters, etc. are warranted for a period of twelve (12) months from the date of installation or eighteen (18) months from the date of the manufacturer.
- g. Riello and its authorized wholesaler/distributors reserve the right to inspect and or test components returned under warranty. A component found to be defective-free may result in a charge to the claimant.

THIS WARRANTY IS LIMITED TO THE PRECISE TERMS SET FORTH ABOVE AND PROVIDES EXCLUSIVE REMEDIES EXPRESSLY IN LIEU OF ALL OTHER REMEDIES. IN NO EVENT WILL RIELLO BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY NATURE. Riello neither assumes nor authorizes any person or company to assume any other liability or obligation in connection with the sale of any Riello product. Riello's liability and customer's exclusive remedy being limited to the replacement as set forth above.
